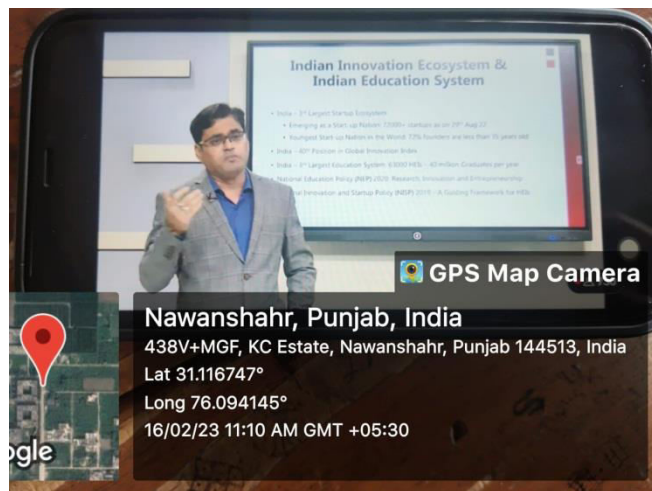

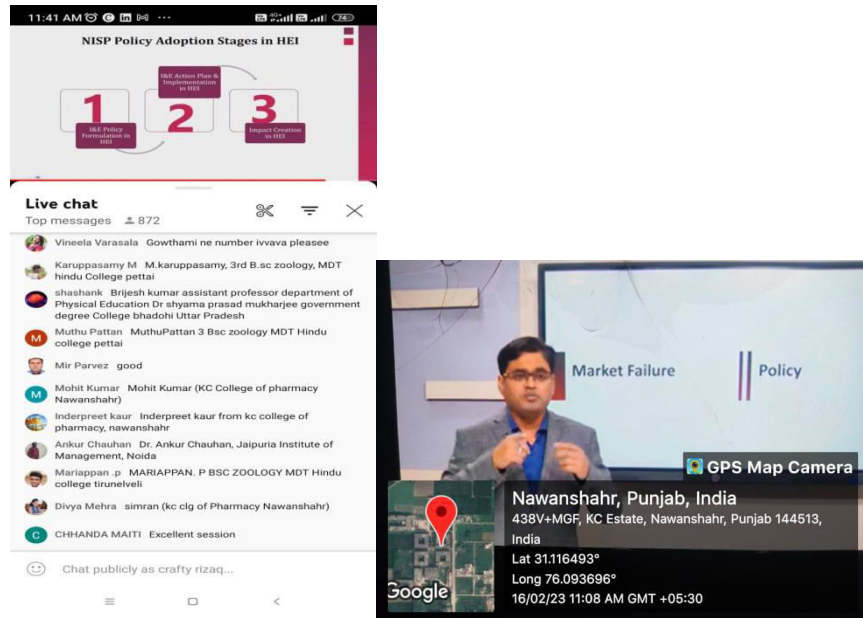
OBJECTIVES

Event Summary

The workshop started at 11:00 a.m. Where Mr. Dipan Sahu Assistant Innovation Director MOE’s Innovation Cell elaborated step by step in detail about whole process of implementing innovation and Start-up Policy where he talked about Indian Innovation Ecosystem and Education System. He explained that India is on 40th position in Global Innovation Index, he further talked about National Education Policy 2020 under which there is reduction in curriculum but the motive is to provide quality education to bring out productive, creative and innovative students. The policy demands research and innovation based institutions ensuring holistic and multidisciplinary education. Later he highlighted the features of the policy and explained that the policy includes the provisions like ‘Innovation Fund’ to support innovative projects and start-ups. It would provide a semester or a year’s break to work on it, there would be complete ownership of IPR by the inventors in case of non-usage of institute’s resources. He also talked about the thrust areas of NISP2019. Mr. Sahu focused on the synchronization and integration of policy programs from policy formulation to implementation till impact creation. He also explained the NISP policy adoption stages in HEI followed by assessing

entrepreneurial ecosystem in HEI. Mr. Sahu encouraged institutionalizing the innovation and entrepreneurship ecosystems in higher education institution. He explained the steps for policy formulation in detail and at last shared their teams contact details to resolve the queries.
