2. If any collaborative projects and/or funding proposals are undertaken, a detailed collaboration agreement will be negotiated between the two organizations.
3. Both the organizations agree that all financial agreements necessary to implement this MoU or any subsequent agreement must be negotiated according to the regulations of each institution and depends on the availability of funds. Both the institutions recognizes that:
  - a) This MoU establishes the foundation of mutual understanding and interest and does not itself entails any financial obligations to either institution.
  - b) This MoU will take effect from the date of its signing and shall be valid for the period of five years from that date, unless terminated earlier upon six months notice by either institution.
  - c) This MoU may be revoked or modified by mutual agreement between the institutions and may be extended beyond its initial five years term by mutual agreement.
4. Biomedical waste management will be done by Mohindra Hospital, Nawanshahr under CPC Guidelines.

This MoU is being signed on 29.01.25 and will stand effective from same date.
